

FISHING RULES ON LAKE PUSIANO

WHAT IS REQUIRED TO FISH ON LAKE PUSIANO?

The fisherman must be in possession of a valid Italian fishing license, a catch record card issued by the Lombardy Region Authority (valid for the current year) and of a valid fishing permit for lake Pusiano issued by the **Lgirent Services** society at the Info Point of Pusiano (CO), 3O via Mazzini. Foreign citizens, too, must be in possession of a Government Licence, a catch record card and a valid fishing permit for Lake Pusiano. All fishing activities on Lake Pusian shall only be allowed if they are in complaince with **Lgirent Services** Fishing Regulations as well as with national, regional and provincial rules.

The payment form for the government licence is available at the **Egizent Services** Info Point. The fisherman must pay a fee of € 23.00 to the postal account n. 25911207 addressed to: Regione Lombardia Tassa concessione per la pesca Servizio Tesoreria. The postal bulletin must indicate the personal details of the fisherman with the following reason: "fishing licence type B". The payment receipt must be shown in the event of checks along with an identity document.It is

The payment receipt must be shown in the event of checks along with an identity document. It is also possible to pay the Government License by bank transfer to the following current account: IT95 D030 6909 7901 0000 0300047.

Children up to the age of 16 and adults over 65 are exempt from paying the shore fishing license. All persons referred to in Article 3 of Law 104/92 (disabled persons) are exempted from paying the Government License and the shore fishing permit. In the case of different types of fishing, the government license and the fishing permit are required.

HOW TO FISH IN PUSIANO?

The website www.lagopusiano.com contains all the information about Services, Carpfishing booking methods, Regulations, Affiliated facilities and Price list. To book a Carpfishing postit is necessary to follow the online procedure and choose one of the available periods from the calendar. For all other fishing types, it is necessary to request a daily, weekly, monthly, semi-annual or annual permit before starting the activity at the Info Point of Pusiano, via Mazzini 30.

WHERE TO FISH IN PUSIANO?

It is possible to fish along the entire perimeter of Lake Pusiano, with the exception of floating docks and private properties. It is forbidden to fish in the canal that starts from Comarcia and until the end of the same. In order to protect carp reproduction, temporary prohibitions may be established which will be reported by the staff in charge.

WHEN TO FISH IN PUSIANO?

It is possible to fish in Pusiano throughout the year, holidays included. For the protection of fish fauna, temporary fishing prohibitions may be established and communicated by the staff of **Egitent Services**. The Egirent Services staff is available for fishermen from 8 am to 6 pm (at any time in case of emergency) at the following number phone: **342.6831440**. RECREATIONAL FISHING RULES IN THE WATERS OF LAKE PUSIANO

PREMISE

Egirent Services srl, owner of the Fishing and Navigation Rights on Lake Pusiano, operates on Lake Pusiano with the mission of making this enchanting lake basin an authentic paradise for local, Italian and international fishermen. **Egirent Services** Srl makes transparency and dialogue the cornerstones of its activity and works at 360 degrees for the promotion of Lake Pusiano.

For these reasons, **Egirent Services** or reserves the right not to grant the fishing permit to those who, at their own discretion, have bad behaviors or cause moral and image damage to Lake Pusiano. Similarly, **Egirent Services** or will have the right to cancel permits already issued to those fishermen who demonstrate disagreement with the corporate philosophy of the protection and care of the Lake.

Egirent Services srl, moreover, specifies that the application of the Price List will come into force on January 1 of each year and will be valid for the folloqing 12 months along all the shores of the lake unless different agreements with coastal municipal administrations.

Wishing all guests of Lake Pusiano a happy stay and a healthy environment-friendly good time, **Egirent Services** srl thanks you for choosing the services offered.

FISHING REGULATION

1. Fishing activities on Lake Pusiano must respect the provisions of this regulation as well as national, regional and provincial fishing rules.

2. ALL FORMS OF PROFESSIONAL FISHING ARE FORBIDDEN ON LAKE PUSIANO

Recreational fishing on the Lake Pusiano is permitted only to those who are in possession of a fishing permit issued by **Egizent Services** SrI as well as of the Governmental Fishing License and the catch record card. Only residents of the municipalities bordering Lake Pusiano must be in possession of a compulsory card for shore fishing to be requested from the **Egizent Services** srI of the cost of € 10 per year.

The rate may be changed in the light of different agreements between **Egirent Schrices** srl and the Municipal Administrations. Anyone found missing this card will have to pay the full amount of the daily Fishing permit. For all other fishing forms, the fisherman must pay the regular fishing license of Egirent Services Srl.

3. SHORE FISHING - PERMIT PAYMENT EXEMPTIONS

Residents of the Municipalities bordering Lake Pusiano, children up to the age of 16 and people over 65 are exempted from paying the permit.

Subjects referred to in Article 3 of Law 104/92 (disabled persons) are exempted from paying the Government License and the shore fishing permit.

In the case of different fishing types, the government license and the relative fishing permit are required.

4. SHORE FISHING

Shore fishing is managed by **Egirent Services** srl. Shore fishing is permitted to all those who are in possession of a Government license, a catch record card and a fishing permit, paid according to the various forms offered, issued by **Egirent Services** Srl. Furthermore, **Egirent Services** Srl specifies that the application of the Price List will come into force on January 1st each year and will be valid for the following 12 months along all the lake shores, unless otherwise agreed with coastal municipal authorities.

Carpfishing stations must be left free from the moment the fisherman who booked it arrives. Anyone who is fishing in these areas is asked to move on arrival and continue his fishing activities at least 50 meters from the spot.

5. BELLY BOAT FISHING

Belly Boat Fishing is permitted to those who are in possession of a government license, a catch record card and a valid fishing permit issued by **Egirent Services** Srl. For each boat, the use of 2 rods per fisherman is allowed, for a maximum of 6 rods per boat during the fishing action. Trolling is prohibited from February 15th to May 31st (max 10 natural baits).

It is absolutely forbidden to moor at the buoys of the wood cases identified in yellow and properly indicated with special wording on them. Violators will be punished with the immediate withdrawal of the permit. IMPORTANT: All holders of a belly boat fishing permit are allowed to fish from the shore without any further permit / cost.

6. CARPFISHING

Permitted in "NO KILL" mode only - with absolute prohibition of fish retention: it is therefore FORBIDDEN to use the fish retention bag in the fishing post. From May 1st to June 30th, only fishing with natural baits is allowed and the use of boiles is prohibited. Carpfishing is allowed only to holders of a government license and a regular permit issued by **Egizent Services** Srl.

The payment of the Fishing Permit includes the possibility of using the services that **Egirent Services** makes available to its customers: - Video-monitored parking - Surveillance - Drinking water supply - Fishing equipment transport- Cleaning service ad waste collection - Chemical toilet.

The fishing station must be left free and in order by 10 am on the day of departure, unless otherwise agreed with the **Egircut Services** staff

Only deep fishing with sinking lines is allowed. Launch carpfishing is allowed during daylight hours. The back led is strictly required.

Egirent Services Srl declines all responsibility for eventual damage to the fishing equipment as a result of non-compliance with this regulation. The use of the boat or other forms of vessel is allowed during the day exclusively to reach the fishing station and for baiting. Fishermen are required to keep on their boats a number of safety equipment equal to the number of people present on the boat. During the baiting and spot research activities it is forbidden to have fishing rods on board. It is also not allowed to drop the lines near boats engaged in fishing activities during daylight hours. During the night the use of the boat is exclusively allowed to bring the baits to the fishing spot and to recover the fish. During the night, only launch fishing is permitted. The baiting spot must be indicated by a buoy bearing the name, surname and permit number (or pass) of the fishing permit holder. On the fishing spot it is mandatory to use special green or mimetic tents (Carpfishing tents, max for two persons) with absolute prohibition to place gazebos and / or tarpaulins. On the fishign spot, it is forbidden to light fires and leave rubbish or other materials. The fishing site must be properly cleaned after use. In case of infringement, this will be communicated to the agents of the Voluntary Ecological Guards of the Valley of Lambro Park. On the fishing site, fishermen are requested to maintain a decent attitude in order to respect both nature and the other users of the lake shores and waters.

Assistance and return of fishermen from the fishing posts:

- The accompaniment of fishermen to the fishing posts will follow the order of arrival (time) at the Info Point in Pusiano (CO).
- the time of return from the fishing stations will have to be agreed and booked by phone with the staff of *Egitent Schwices*. Srl. For a better service, the loading and unloading operations from the cars / vans must be carried out quickly.

The use of the specific posts is managed through a mandatory booking service by Egirent Services Srl. When a post is free, it is not possible to take possession of it again without a regular authorization issued by Egirent Services Srl. Failure to comply with the above-mentioned rules will result in the immediate withdrawal and cancellation of the Fishing permit without refund and for the entire year.

Any fisherman found without a fishing permit or in an illegal location will have to compensate the company that owns the exclusive fishing right with compensation ranging from \in 5,000 to 15,000. The following specific temporary fishing bans have been established within the exclusive fishing rights of Lake Pusiano, which will come into force at the time of carp reproduction, after verification of the staff in charge. These areas will be duly delimited.

- ZONE 1: Fishing ban near the cane field in the area called Comarcia Bosisio Parini.
- ZONE 2: Fishing ban near the cane fields in the area called Baja di Casletto in Rogeno.
- ZONE 3: Fishing ban near thecanw field in the area called Ansa di Moiana, Merone.

7. SQUARE FISHING NETS

The use and detention of the square fishing nets is not permitted, offenders will be punished with the immediate withdrawal of the fishing permit and the cancellation thereof without refund and for the entire current year. Against those who will be found in possession of a square fishing net, **Egirent Services** srl reserves the right to claim damages.

8. FISHING PERMIT ISSUE

Fishing permits (as reported in points 1, 2, 3 and 4) are issued by Egirent Services Srl. All information can be consulted on the website www.lagopusiano.com or by sending an email to amministrazione@lagopusiano.com or by calling the following number: +39 342 6831440. The acquisition of the **Egirent Services** srl fishing permit entails the full acceptance this fishing regulation. In case of non-acceptance of these regulations, it will not be possible to issue the fishing permit. The fishing permit is nominal and not transferable to third parties. The fishing permit must be strictly requested and obtained before starting the fishing activity. Otherwise, **Egirent Services** srl will proceed as follows: - The people who will be found intent in fishing activities on Lake Pusiano without a regular fishing permit issued by **Egirent Services** Srl will be required to pay the amount due four times more than the original value of the permit itself. - At the time of the check, no justification regarding non-possession of the permit will be taken into consideration due to the obligation to take possession of the fishing permit before starting the fishing activity.

In order to request the fishing permit, it is necessary to call the phone number 342.6831440 or send an-mail to vigilanza@lagopusiano.com to make sure that the *Egirent Services* Srl staff is available at the headquarters and not engaged in activities that require their presence on Lake Pusiano.

9. CLOSED PERIODS, SPECIES AND MININUM SIZES ALLOWED

^{*}the total number of fish must not exceed 5 kg in weight.

Failure to comply with these regulations will result in the immediate withdrawal and cancellation of the Fishing permit without refund and for the entire current year.

10. FISHING OF UNDESIRED EXOTIC SPECIES

The unwanted invasive species that can be found on Lake Pusiano are the following:

Abramis
 Gardon
 Silver Bream
 Carassius
 Aspius
 Torpedo fish
 Rodeo

- Exotic barbel - Gymnocephalus - Catfish (all species)

These species can be caught without any catch limit. The specimens belonging to these species, once captured, cannot be reintroduced into the water but must be suppressed and not abandoned at the fishing site.

11. PARTICULAR BANS

It is strictly forbidden: to fish from all jetties (fixed and floating). Access private properties without permission in order to reach the fishing spots. To dock, damage and remove the signaling buoys for fish repopulation located in the lake and indicated by appropriate signs on the buoys themselves.

From March 15th to May 30th, fishing with live fish less than 20 cm in length is prohibited; in the same period, fishing is allowed with the use of live fish with length not less than 20 cm exclusively for catfish fishing.

It is forbidden to create woodsheds of any type and entity. Unauthorized entry of fish of any type is prohibited.

The woodsheds owned by *Egirent Services* SrI are specially marked with floating yellow buoys and numbering label. No one is authorized to manage, modify or perform any other operation not authorized by the company *Egirent Services* SrI. All boats can sail only under electric motor or in rowing mode. Belly boat fishing is not allowed in case of strong wind and fog. Any type of intervention not authorized by *Egirent Services* is prohibited.

In order to protect fish fauna, a protection period has been established that will be communicated by **Equirent Scrvices** at any time.

Permanent fishing bans: in the whole channel from Comarcia to the end of it.

Egirent Services Srl declines any civil or penal responsibility, damages to persons or things deriving from non-compliance with the rules of this document.

Failure to comply with these rules will also result in the immediate withdrawal and cancellation of the Fishing Permit without refund and for the entire current year.

12. EGIRENT SERVICES SRL SPECIAL PENALTIES


In case of violation of the provisions laid down by current regulations and laws, **Egitent Services** Srl may withdraw the fishing permit from the holder, who will be subject to this provision even if the violation is carried out by other fishermen present on the boat of the permit holder, without any obligation of refund or compensation.

The permit will be returned after a period of suspension of no less than 15 days, established by Egirent Services Srl with the possibility of revocation of the same indefinitely on the basis of the infringements committed.

In any case of violation of the regulations that led to the capture or unlawful killing of fish fauna or other ascertained damages, **Eginent Services** Srl will have the right to request a compensation that will include the costs for the fish re-entering intervention and any restoration of environmental damage.

No one is authorized to start fishing without having first purchasing the fishing permit. It is also not allowed to request fishing permits by phone: it must be requested only at the Info Point located in Pusiano, Via Mazzini 30. Damage to or removal of the signaling buoys bearing the indication "natural wood shed" will give **Egirent Services** Srl the faculty to request compensation for the damage that will also include the costs of damage restoration.

Egirent Services Srl has the right not to grant the fishing permit to unwanted or repeat offenders



Surveillance is performed by Provincial Fishery protection Guards and by the volunteer staff authorized by *Cgirent Services** Srl. The Provincial Police Agents and the Police Forces can also provide for the verification of the infractions. The surveillance activity carried out privately by *Cgirent Services** srl, as well as related to the Fishing and Navigation sector, also takes care of monitoring the lake shores and ecosystem. All holders of the fishing permet issued by *Cgirent Services** Srl consents and immediately authorizes the control of the permit itself even by Egirent Services Srl authorized volunteer staff (with identification card). In case of refusal to exhibit this document to the volunteer staff of *Cgirent Services** Srl, the fishing permit will be immediately withdrawn and canceled without refund. At the time of withdrawal of the fishing permit, the signature for acceptance of the same is also valid as acceptance without any reservation of the aforementioned regulation. Any information concerning the exercise of the Exclusive Fishing and Navigation Rights within Lake Pusiano may be communicated or released exclusively by the *Cgirent Services** Srl staff in possession of the appropriate identification card. Nobody else has this faculty. In case of violation, this will be prosecuted according to the law. *Cgirent Services** Srl reserves the right to modify the present fishing regulation in a more restrictive manner at any time without prior notice.
